Greetings from the Mendenhall Cemeteries Association (MCA) and Board of Directors

Our efforts at MCA are only possible through timely and recurring gifts from our member families and friends like You.

Over the past year (July '22 through June '23), MCA had projects in many areas – here are a few you might find interesting:

- Contacts centralized and updated: We moved all our contact information to a computerized system to allow us to access our families more readily.
- Alley trees removed: In October '22, we were able to conclude the removal of problem trees between Section A and the County Sherriff's Office property. The stumps will have to be removed later, as they contained net wiring that prevented chain saw cutting.
- Headstone cleaning: MCA is now equipped and experienced to provide this service as needed.
 Families can request headstone cleaning through our website – there will be a charge according to the size and condition of headstones.
- Offsite storage moved to Church of Mendenhall Bus Barn: The Church of Mendenhall (formerly Mendenhall United Methodist Church) donated a corner of their bus barn for MCA supplies. We concluded this transfer in March '23 - Thanks to Church of Mendenhall for use of their facilities.
- Bulletin board update: We updated our Cemetery Bulletin Board with a rendition of the new MCA logo and posting legal notices etc.
- Website calendar and mowing schedule: Our website now has a calendar which shows meeting dates and scheduled events.
 Additionally, we also included the scheduled mowing dates for your reference.
- Financial budget reporting: With the addition of a CPA to our board of directors, we now have financial reporting with budget comparisons.


